



## 2009 TIRE RACK® SCCA DIVISIONAL CHAMPIONSHIPS CONTINGENCY PROGRAM CLAIM FORM

**REGISTRATION:** Competitors must be officially registered to participate in the program before the date of the event in which you will be competing. No awards will be paid if you are not enrolled prior to competing in an eligible event. Additionally, competitors must complete and submit this Claim Form no later than 30 days after the final divisional event, and submit one W-9 form to the SCCA prior to distribution of posted awards each year.

**REQUIREMENTS:** Competitor must use Bridgestone tires on all 4 wheel positions during all runs at each event for which points are accumulated; and must display 3 or 4 Bridgestone decals: Bridgestone (min. 12") centered on the front bumper or one on each side of the front bumper and Potenza RE-11 (min. 24") over each front wheel. Decal color must contrast with the vehicle color. Decals are provided by SCCA and will be available on-site in the tech area at each Tire Rack® SCCA Divisional Championships event.

**VERIFICATION/AWARD PAYMENT:** *Product use and decal placements must be verified on-site at each divisional event by the Divisional Steward or Chief of Compliance - who must sign this claim form.* Competitors should retain this form for submission within 30 days of the completion of the Division season. Completed claim forms must be submitted with a copy of the final division point standings (standings not required if the Division Championship is a single event), and official event results for each event in which points were accumulated. Award eligibility will be verified upon receipt. Payment is issued by SCCA within 30 days of claim receipt.
