Requirements:	<ul style="list-style-type: none"> • Competitor must use Bridgestone tires on all four wheel positions during all runs at all eligible events. • <u>Decals Required:</u> YES • <u># of Decals:</u> 3 or 4 • <u>Location:</u> Bridgestone (min. 12") centered on the front bumper or one on each side of the front bumper and Potenza RE-11 (min. 24") over each front wheel. • <u>Availability:</u> Decals will be available on-site in the tech area. All decals must be Black, White, Silver or full-color as displayed, no other colors permitted. Selected decal color must contrast with the vehicle color.
